


About Carolina Complete Health

Overview of Value-Added Services

Standard Plan Benefits vs. Value-Added Services

Standard Plan Benefits

- The NC DHHS requires that all Medicaid plans provide Standard Benefits such as doctor visits, hospitalization, preventive services, and prescription drugs.
- Standard Benefits are the same for all five plans in North Carolina. Copays for Standard Plan Benefits are also the same.
- Standard Plan benefits do not differentiate one plan from another.

Value-Added Services

- As part of the transition to Medicaid Managed Care, NC DHHS was committed to increasing support for Social Determinants of Health (SDOH) such as education, food insecurity, transportation, etc. Research shows that SDOH can impact up to 80% of health outcomes.
- NC DHHS invited the five Medicaid Managed Care plans to submit/file their Value-Added Services with some guidelines including a cap of \$75 for rewards to incent healthy behaviors. Nonmonetary Value-Added Services can exceed \$75.
- Every Medicaid Managed Care plan in NC has a suite of Value-Added Services. Prospective members can view each plan's extras on the broker materials, NC DHHS website, and health plan websites.
- There is no cost to members for Value-Added Services.
- The state refers to these as Added Services, Carolina Complete Health refers to them as Value-Added Services, and other plans refer to them as Extra Benefits or Additional Benefits.

Room to Breathe My Health Pays[®] Rewards Card All Carolina Complete Health members receive a My Health Pays® Visa® Card within two weeks of

enrollment. Members can earn dollars that are loaded on the card for completing healthy activities, such as a Care Needs Screening or Annual Wellness Visit.

New Parent's Package

Carolina Complete Health members who are expecting a baby or have delivered a baby within the past 12 months can receive their choice of a car seat and diapers OR an electronic breast pump and diapers. One Parent's Package per member per plan year valued at up to \$150.

24 Hours of Online Tutoring

Carolina Complete Health members enrolled in kindergarten through 6th grade can get up to 24 hours of math and/or reading tutoring per plan year. A parent/guardian consent form must be completed.

Carolina Complete Health's Value-Added Services are easy for members to access through our website at www.carolinacompletehealth.com/vas. In most cases, the member can simply fill out a webform using their smartphone or computer to request the Value-Added Service. Members can also call 1-833-552-3876 to request a Value-Added Service.

Room to Breathe Asthma Support Program



What is this Value-Added Service?

 Care management support with up to \$150 in supplies to help minimize triggers of asthma including hypoallergenic bedding, cleaning supplies, HEPA air purifier, dehumidifier, HEPA vacuum, or pest control products.

Who is eligible for this Value-Added Service?

• Members who have been diagnosed by their primary care provider with asthma. Health risk assessment required.

How do members get this Value-Added Service?


 Members must fill out the webform on the website or contact member services at 1-833-552-3876. Members will be connected to a care manager to discuss triggers of asthma and activities to help control it. Care manager will work with parent/guardian to identify supplies that may help minimize asthma for the child.

• Members must fill out the webform on the website or contact member services at 1-833-552-3876. Members will be asked to provide their height and weight to calculate BMI and determine eligibility.

YMCA Blood Pressure Self-Monitoring Program

What is this Value-Added Service?

- The virtual four-month YMCA BPSM program offers personal support for members to build skills that help them manage high blood pressure, notice and control triggers that raise blood pressure, and eat healthier.
 - Studies show that taking your blood pressure at least twice a month for four months lowers your blood pressure.
 - Twice a month, participants attend the program and receive personal coaching, as well as attend monthly nutrition meetings.

Who is eligible for this Value-Added Service?

 The program is available to Carolina Complete Health members age, 18 years or older who have been diagnosed with high blood pressure. Participants cannot have had a recent cardiac event, have atrial fibrillation or other arrhythmias, or be at risk for lymphedema.

Back to School Supplies

What else does this program offer?

- Education is important at Carolina Complete Health. Members enrolled in Pre-Kindergarten-12th grade receive basic school supplies.
- Eligibility You must be a current Carolina Complete health member currently enrolled in grades Pre-Kindergarten through 12th grade to receive this Value-Added Service. One school supply set per school year. Orders accepted for this Value-Added Services are open from June 1 - August 31st. Member must be at least 3 years old.
- Orders are accepted June 1-August 31, 2025. Backpack shipments will begin in mid-August. Thank you for your patience as orders are prepared and fulfilled. Supply items cannot be sent to P.O. boxes, and a responsible party must sign for the delivery of the package. For assistance, please contact us at <u>1-833-552-3876</u> (TTY 711). This Value-Added Service requires the recipient or a responsible party to sign for the delivery of their package.

Questions and Answers



For the New Parent Package, should it be processed under the mother or baby?

 It can be processed under either the mother or the baby. Provide Medicaid ID(if available) &/or if the parent is covered, they can list their Medicaid ID on behalf of the child and indicate the parental status on the form.

What is the turn around time for receiving the New Parent Package items?

• Processing takes 4-6 weeks; items shipped w/in 48-72 hours of processing

Is a Health Assessment required to receive VAS?

• Room to Breathe and Care Grants require a health risk assessment and New Parent Packages require a NOP.

Do care grants have to be processed through Care Management? How does it work if the member is in an AMH Tier 3 practice?

Care grants must be processed through the health's plans Case Management Team, criteria is listed here
 <u>https://www.carolinacompletehealth.com/members/medicaid/resources/vas/care-grant.html</u>. After member reviews the criteria they will need to outreach to internal CCH CM for request, then a referral will be made to the delegated CM (Tier 3) to inform them of the request.



What steps are being taken to improve the involvement of providers in patient care coordination to reduce hospitalization rates, med management and improve patients over well-being?

• Care Managers will often be in contact with providers to assure linkage to follow-up care postdischarge. Also, during the course of ongoing case management, the CMs may be in contact with providers to engage in planning and care coordination for referrals, consultation etc. with the goal always being improvement of member outcomes including avoiding unnecessary readmissions.

Is there a potential for the distribution of Visa gift cards through the "My Health Pays" VAS program to reward members at the time of their appointment upon completion and if this is even feasible?

 My Health Pays[®] loyalty/rewards for incentivized healthy behaviors cannot be paid until provider claims are received and processed. My Health Pays reward dollars are added to the member's rewards card after CCH processes the claim for each activity completed. My Health Pays Visa[®] Prepaid Card will be mailed to members approximately 2 – 3 weeks after they become eligible with Carolina Complete Health.





Is the WeightWatchers program available for teenage CCH members?

• At this time, members must be age 18 years or older with a BMI equal to or greater than 25.

Is there support for care gap closures and getting the reports?

 with HEDIS/care gap reviews and monitoring performance patterns through reporting. You can reach

What programs or supports does CCH have for members with diabetes?

• If the member currently has diabetes, CCH Care Management can support the member in receiving needed diabetic supplies. CCH also has a Diabetes Prevention Program through our Value-Added Services. The program is available to Carolina Complete Health members age 18 years or older with prediabetes, a Body Mass Index (BMI) of 25+ (Asian individual(s) with BMI of 23+) and have an A1c between 5.7% - 6.4.
