Step 1

Log into the Secure Provider Portal at <u>https://provider.carolinacompletehealth.com/</u>.

Step 2

Health departments may show two sets of reports for each month, one set for CMARC and CMHRP and one for Medical Home and Tier 3 Care Management, if applicable. Medical Home PMPM and Tier 3 CM (if applicable) are combined into one report.
