Maternal Health Quick Tips

Carolina Complete Health is committed to achieving the best health outcomes for members during and after their pregnancy. This reference guide is designed to help you better understand Prenatal Timeliness HEDIS® measures to close care gaps and obtain information about programs and resources to support you and your patients.

Measure Indicators

Timeliness of Prenatal Care: Prenatal care visit during 1st trimester, on or before the date of enrollment or within 42 days of enrollment with Carolina Complete Health.

Postpartum Care: Postpartum visit with provider must occur on or between 7 and 84 days after the baby is delivered to close the HEDIS° measure. During the visit this is an opportunity to:

- Screen the mother for depression, anxiety, substance use, etc.
- Discuss family planning (18-month spacing between pregnancies) and contraception.

Best Practice Tips

- Ensure prenatal care visit in the first trimester, on or before the enrollment start date or within 42 days of enrollment in the organization and postpartum visit is completed 7-84 days after delivery.
- Send out reminders of appointments (e.g.: mail, email, text, and calls).
- Ensure that a Notification of Pregnancy form has been sent to Carolina Complete Health.
- Encourage member to attend all scheduled prenatal visits.
- Submit claims/encounter data for each and every service rendered.
- Ensure all claim/encounter data accurate and submitted in a timely manner.
- Prenatal visits must be completed by an OB/GYN, other prenatal care practitioner, or PCP. Visits completed by a PCP must include a diagnosis of pregnancy.
- Use prenatal visits as an opportunity to discuss the mother's immunization record, educate member about vaccines, and complete other screenings (e.g.: BH, postpartum).
